#### \$100,000 Pyramid of Debt Game Show Overview

# Hon. Martin R. Barash, Central District of California (San Fernando Valley Division)

United States Bankruptcy Judge Martin R. Barash sits in Woodland Hills and Santa Barbara, California. Prior to his appointment, Judge Barash was a partner at Klee, Tuchin, Bogdanoff & Stern LLP (now called KTBS Law) in Los Angeles, from 2001 to 2015, representing debtors and other parties in chapter 11 cases and bankruptcy litigation. He first joined the firm as an associate in 1999. Earlier in his career, Judge Barash worked as an associate at Stutman, Treister & Glatt P.C. in Los Angeles. He also has served as an adjunct professor of law at California State University, Northridge. Born in Los Angeles, Judge Barash earned his A.B. in 1989 from Princeton University, where he graduated magna cum laude in Politics, and with a certificate with distinction in American Studies. He earned his J.D. in 1992 from the UCLA School of Law, where he served as editor, business manager, and symposium editor of the UCLA Law Review. Following law school, he clerked for Judge Procter R. Hug, Jr., of the U.S. Court of Appeals for the Ninth Circuit, from 1992 to 1993. Judge Barash is a former member of the board of directors for the American Bankruptcy Institute and its Education Committee, and now serves on its Committee for Diversity, Equity, and Inclusion. He is a former member of the Board of Governors of the Financial Lawyers Conference and currently a Judicial Director of the Los Angeles Bankruptcy Forum. He is a frequent panelist and lecturer on bankruptcy law and is a co-author of the national edition of the Rutter Group Practice Guide: Bankruptcy.

## Hon. Neil W. Bason, Central District of California (Los Angeles Division)

Judge Bason was appointed to the bench in 2011, and sits in downtown Los Angeles. In private practice he represented a wide variety of interests in commercial bankruptcy and insolvency matters including secured and unsecured creditors, trustees, receivers, debtors/borrowers, guarantors, prospective asset purchasers, and other parties in interest. He practiced at Howard Rice Nemerovski Canady Falk & Rabkin, P.C. (subsequently combined with Arnold & Porter Kaye Scholer LLP) and at Duane Morris LLP. Before that he clerked for the Honorable

Dennis Montali, Bankruptcy Judge of the Northern District of California and Chief Judge of the Bankruptcy Appellate Panel of the Ninth Circuit. He graduated magna cum laude from the Boston University School of Law in 1988, where he was a Note Editor on the law review. He enjoys dining, and working off the resulting calories with biking, hiking, and travel.

# Hon. Hannah L. Blumenstiel, Northern District of California (San Francisco Division)

The Ninth Circuit Court of Appeals appointed Judge Blumenstiel to the United States Bankruptcy Court for the Northern District of California (San Francisco) on February 11, 2013.

Prior to her appointment, Judge Blumenstiel was an associate (2003 - 2008) and then a partner (2008 - 2012) with Winston & Strawn LLP, where she focused her practice on creditors' rights litigation in state and federal court, including bankruptcy court. From 2001 to 2003, Judge Blumenstiel was an associate with Murphy Sheneman Julian & Rogers LLP, where she represented debtors, creditors and trustees in bankruptcy cases and adversary proceedings. Judge Blumenstiel served as Law Clerk to the Honorable Charles M. Caldwell of the United States Bankruptcy Court for the Southern District of Ohio (Eastern Division) from 1998 to 2001. From 1997 to 1998, Judge Blumenstiel represented the State of Ohio's interests in bankruptcy cases as an Assistant Attorney General with the Revenue Recovery Section of the Ohio Attorney General's Office. Judge Blumenstiel earned her Juris Doctorate from Capital University Law School in 1997. During her first two years of law school, she worked full-time for the Columbus Bar Association as Director of its pro bono initiative "Lawyers for Justice." Judge Blumenstiel received her B.A. from The Ohio State University in 1992.

Judge Blumenstiel was appointed to the Board of Directors of the American Bankruptcy Institute in April 2018 and serves as an Executive Editor of the ABI Journal.

## Hon. M. Elaine Hammond, Northern District of California (San Jose Division)

M. Elaine Hammond is a United States Bankruptcy Judge for the Northern District of California in San Jose. A native of North Carolina, she received her undergraduate degree from Duke University, and her JD with honors from the University of North Carolina School of Law. Prior to taking the bench in 2012, Judge Hammond's practice focused on representing debtors and creditors in commercial bankruptcy cases and out-of-court restructurings. ## Hon. Margaret M. Mann, Southern District of California

Bankruptcy Judge Margaret M. Mann was appointed a U.S. bankruptcy judge for the Southern District of California on April 2, 2010. She is currently the chair of the Ninth Circuit Conference Executive Committee and the Ninth Circuit representative to the Bankruptcy Judges Advisory Committee of the United States Administrative Office. Since her appointment, she has served as a faculty member for Federal Judicial Center Education programs. Judge Mann is a fellow with the American College of Bankruptcy and a founding member of the San Diego Bankruptcy Forum. Before becoming a judge, she was listed in Best Lawyers in America, and served leadership roles in numerous bankruptcy and civic organizations, including the State Bar Debtor Creditor Committee, Lawyers Club, Athena and the California Bankruptcy Forum. Before her appointment, Judge Mann was a partner at Sheppard Mullin Richter & Hampton LLP and from 2003 to 2008 she served as chair of the Restructuring and Insolvency Practice and national hiring chair for Heller Ehrman LLP. Judge Mann received her B.A. in finance, cum laude, from the University of Illinois in 1978 and attended the Tilburg School of Economics in The Netherlands in 1978. She received her J.D. from the University of Southern California, Gould School of Law, in 1981. Judge Mann has been active in public service throughout her legal career.
